Prior written notification and consent for the import of waste is not required under national law because previously imported into the country of all kinds of waste was banned. Exceptions to the import of waste were later introduced.

At the moment The Ministry of Agriculture, Regional Development and Environment is working on the drafting of the new Waste Shipment Regulation which will establish new mechanisms to implement the provisions of the Basel Convention, including the provisions on documentation required to be requested at the introduction of waste into the country, liable to import.
